BRIEF DESCRIPTION OF KEY PERFORMANCE AREAS, DUTIES & RESPONSIBILITES:

Main duties & Job Function:

- The qualified and experienced Psychiatrist will have the option to integrate or start their own practice based at a leading Wellness Facility with existing patients and referrals or their choice to function independently.
- Billings will be done as per Medical Aid rates
- There will be various options available from the Wellness Facility to assists with the initial start-up of the practice according to what is required specifically. **To be discussed and confirmed first.
- Psychiatrists are medically qualified doctors specializing in the diagnosis and treatment of patients with mental health disorders such as dementia, depression, bipolar disorder, schizophrenia, and other mental illness.
- They are therefore skilled in recognizing the symptoms of both the mind and body to evaluate, assess risk, and draw up treatment plans, which may include prescribing medication and do admissions to hospital or facility.

Key Performance Areas and Responsibilities: -

- To treat psychiatric conditions of patients and to admit them to the Wellness Facility
- Do assessments, diagnosis, and admissions
- Confirm current diagnosis
- Medical Schemes require the DSM-IV form from the admitting psychiatrist within 18 hours of admission
- Patients needs to be seen at least 3 times a week
- The patients must be seen by the psychiatrist before discharge
- For any earlier discharge, the psychiatrist must inform the Nurses Station
- They also conduct physical examinations, observe behaviours, and review medical history to obtain patient information.
- As part of their duties, psychiatrists select, administer, and interpret psychological tests.
- Work directly with patients suffering from a range of mental health problems and provide a good standard of practice care
- Assess patients by reviewing their mental and physical health, their background and current social situation, thoughts, and past health issues, as well as any potential risk factors
- Take note and keep detailed records of any interactions and decisions
- Decide on suitable psychiatric treatment plans for patients, which may include a combination of medical, psychological, and social interventions in conjunction with other health professionals
- Prescribe medication when necessary
- Monitor and review treatment regularly

- Have excellent knowledge of physiology, anatomy, psychology, pharmacology, and mental health law, as well as an awareness of the social factors that influence mental health
- Work closely within, or lead a multidisciplinary team of health professionals, including psychiatric nurses, psychologists, and occupational therapists.
- Carry out research and keep up to date with new information relevant to their field
- Determine a line of treatment for patients and implement it
- Work with a team of doctors if the patients on their treatment and help them understand the disease
- Exercise lots of patience and care towards each patient
- Counsel the patient and their close relatives
