  - **Like joining the United Nations for standards**
- **1 x Technical Committee is created per subject / field**
  - **ISO/TC 267 = Facility Management**

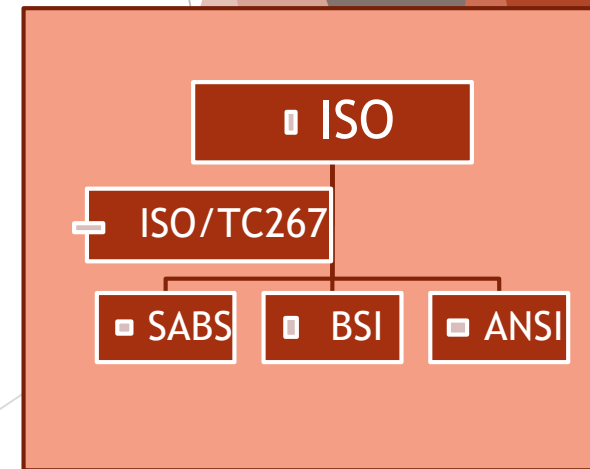




# Standards for FM:

## □ How it Works

- Any country can join ISO
  - Like joining the United Nations for standards
- 1 x Technical Committee is created per subject / field
  - ISO/TC 267 = Facility Management
- **Each country creates its own TC – mirror committee**
  - **SABS TC 267**
  - **TC nominates Subject Matter Expert/s – SME**
- **International group of SMEs write new standards**
  - **New standard take 2 -3 years to develop**
  - **Key principle is rigorous peer review**



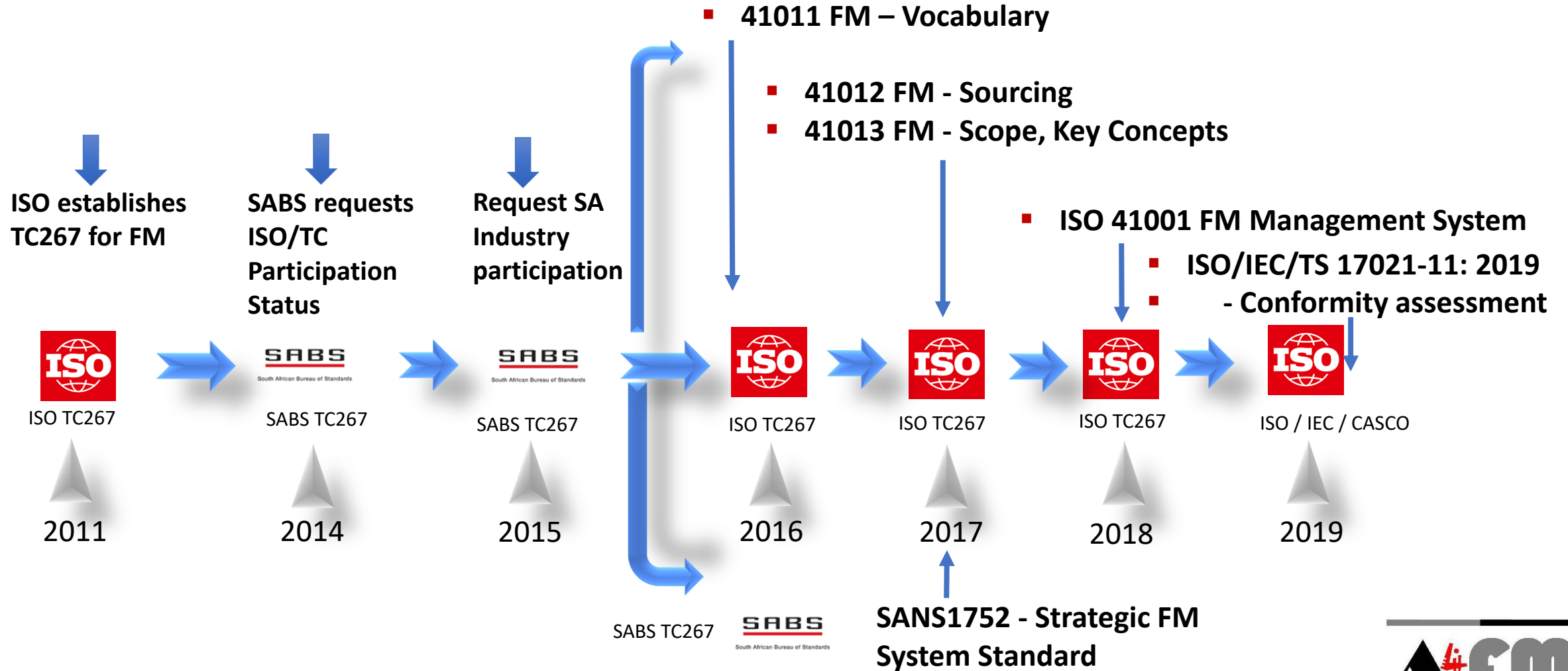

# ISO Standards for FM: What has been achieved

## ISO 41011- Terminology

- One global definition
- Standardised terminology for FM

“Facility Management is an organizational function which integrates people, place and process within the built environment with the purpose of improving the quality of life of people and the productivity of the core business”.



# ISO Standards for FM: What has been achieved

## ISO 41012 - Sourcing

Established international best practice re:

- SLA / sourcing terminology
- Due diligence in decision-making re sourcing
- Guidelines for developing Service Level Agreements
  - some 100 recommendations provided
- User-friendly and useful standard

## ISO 41012 - Sourcing

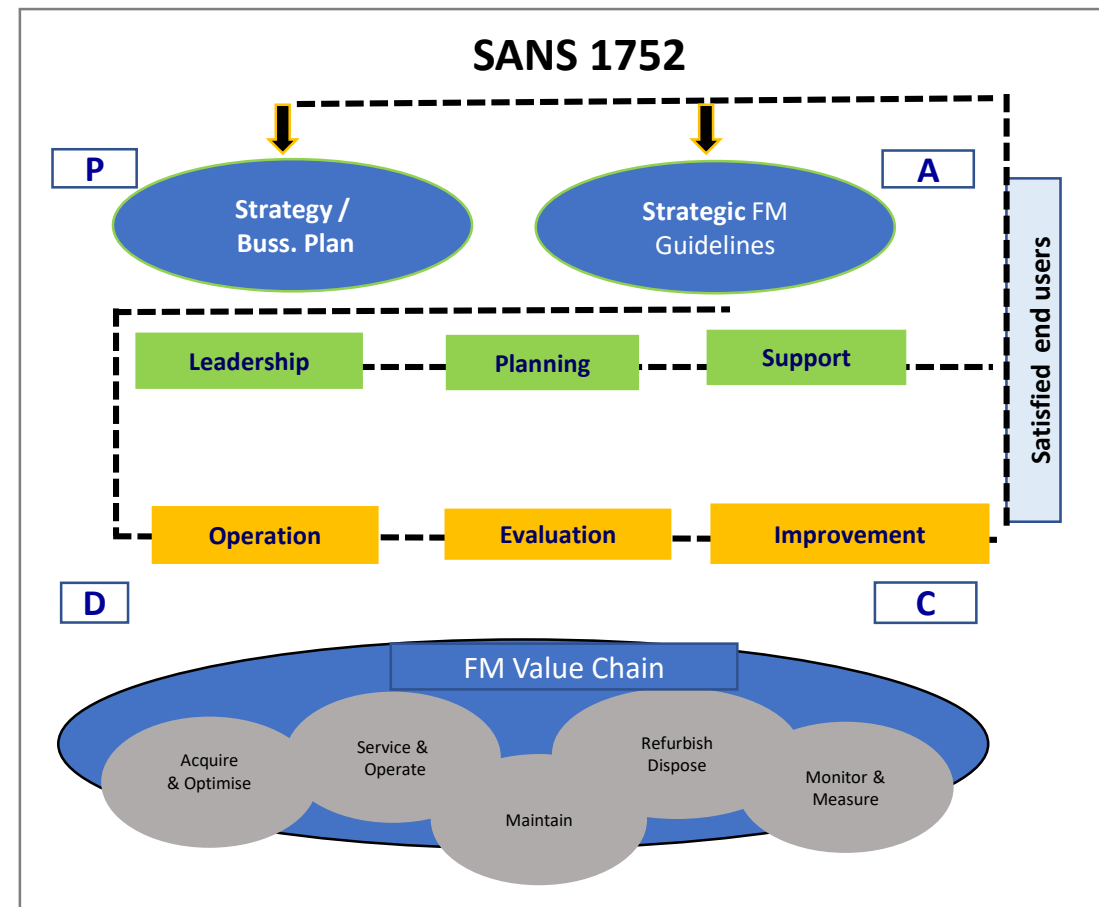

# SANS Standard for FM: What has been achieved

## SANS 1752 – Strategic FM Management System (SFMS)

- Understanding the organisation and its SFMS / its context
- Determining the scope of the SFMS / FM
  - Leadership
  - Planning
  - Support
  - Operation
  - Performance evaluation
  - Performance improvement



# ISO Standards for FM: What has been achieved

## ISO 17021-11 : Conformity



ISO 17021-11 covers:

- Generic competence requirements for FM management systems auditors
- Competence requirements for persons reviewing audit reports and making certification decisions
- Competence requirements for persons conducting the application review to determine audit team competence required, to select the audit team members and to determine the audit time.

# ISO Standards for FM: What is still to come

## Procurement of FM Services by the Public Sector - Scope

- Good practice guide for the procurement of FM by government
- Provide ISO 41000-series alignment & guidance re use of series for procuring services by government sector
- Additional guidance to address peculiarities unique to government business practices
- See government practices from a system horizon & demonstrate positive impact of 41000-series
- Directed at decision maker within government sector – Treasury
- Provide key guidance and understanding on contemporary models of FM
- Demystify areas which drive efficiency vs. areas that create a significant cost impact



# ISO Standards for FM: What is still to come

## FM Technology Task Group – FMTTG Remit:

- Explore the issue of FM and technology
- Define the many aspects of tech(nology) in relation to FMI
- Develop a paper referencing technology implications for FM in a connected world/smart cities
- Developed a road map and a recommendation for a way forward to navigate this domain
- White paper, road map and, if applicable, New Work Item Proposal (Nov. 2019)







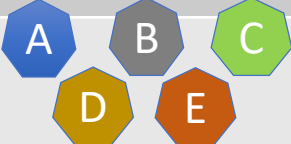

# **ISO/TC 304 Healthcare Organisation Management:**

## **Background**

Standardisation in healthcare organisation management including: classification, terminology, nomenclature, management practices and metrics that comprise the non-clinical operations in healthcare entities.

## **Objectives**

- Develop standards that are relevant to the intended users;
- Achieve the highest quality of standards that can reasonably be developed;
- Focus on the global harmonisation of healthcare organisation management practices that have the promise of reducing the growth of costs, improving overall organisational effectiveness, and optimising organisational efficiency
