INDUSTRIAL CHEMICALS SECTOR SUBSTANTIVE AGREEMENT

1. PERIOD OF AGREEMENT:

This agreement shall apply for the period 1 July 2022 to 30 June 2024. 1.1

2. SCOPE OF AGREEMENT:

This agreement shall apply to employees within the recognised bargaining units of member companies listed hereto in Annexure A.

3. **WAGES:**

For year one the monthly wage will increase across the board by 6%, as from 1 July 2022.

In year two (1 July 2023 to 30 June 2024) the monthly wage will increase across the board by the average CPI plus 1.0% improvement factor, (Average CPI will be the average of the Headline CPI for the 12 months May 2022 to April 2023.) The increase will be subject to a floor (minimum) of a 4% increase and a ceiling (maximum) of a 7.5 % increase.

4. **MINIMUM WAGE:**

The current minimum wage (R8 388.74) will be increased by 6% as from 1 July 2022 to R8 892.06 which is the agreed across the board (ATB) percentage increase applicable to all Industrial Chemicals sub-sectors.

For the period 1 July 2023 to 30 June 2024, the minimum wage will be increased by the average CPI plus 1.0% improvement factor, (Average CPI will be the average of the Headline CPI for the 12 months May 2022 to April 2023.) The increase will be subject to a floor (minimum) of a 4% increase and a ceiling (maximum) of a 7.5% increase.

5. TASK TEAM:

The following matters shall be referred to a Task Team:

· Scope of agreement;

· Shift allowance;

Transport allowance;

Hours of work.

The full Terms of Reference of the Task Team is contained in a separate agreement.

6. EXEMPTIONS:

Companies seeking exemption from the conditions of this agreement and/or any conditions agreed to previously through centralised bargaining between the parties, should do so according to the Council's exemptions procedure.

7. DISPUTE RESOLUTION:

If there is a dispute about the interpretation or application of any clause of this agreement any party may refer the matter to the Council for resolution in terms of the dispute resolution procedure of the Council.

8. OTHER TERMS AND CONDITIONS:

All other terms and conditions not affected by this agreement will remain unchanged. Those benefits already more favourable than provided for in terms of this agreement shall not be affected by this agreement.

9. FULL AND FINAL SETTLEMENT:

The terms of this agreement are in full and final settlement of substantive wages and terms and conditions of employment negotiated for the period 1 July 2022 to

10: **PEACE OBLIGATION:**

Neither party to this Agreement shall engage in any form of industrial action against the other party regarding any disagreement on wages and other substantive conditions of employment during the entire period of this Agreement, unless disagreement arises out of the implementation and/or interpretation of this Agreement, in which case any party may refer the matter to the Bargaining Council for the Chemical Industry for resolution in terms of the dispute resolution procedure of said Council.
